

COOKIE POLICY

A cookie is a small text file which the browsed website sends you and stores on your computer or mobile device and that will be sent back to the same website every new visit. Cookies do not damage your device and allow to offer a better browsing experience.

This website may use technical cookies (strictly necessary cookies, functionality cookies and performance cookies) which do not require your consent to be downloaded on your device, and profiling third party cookies – cookies of a different domain from the one of the website you are browsing – for advertising and marketing purposes, which instead may be downloaded only with your consent.

In particular this website may use these types of cookies:

- **Strictly necessary cookies:** these cookies are necessary for the operation of the website and cannot be disabled. Usually they are set only in response to your actions, which constitute a request of services, such as setting the privacy preferences, access or filling in forms. It is possible to set the browser in order to block or have alerts about these cookies (you will find additional info about it below), but this implies that some website functionalities may not work properly.
- **Functionality cookies:** these cookies allow to browse a website according to a set of selected criteria (as for example the language) and are aimed at improving the service offered; these cookies do not require your prior consent and are automatically set on your device registering the information about choices you made and allowing us to customize the website according to them.
- **Performance cookies (e.g. Google Analytics):** these cookies that may be also of third party allow to know the frequency with which users visit the website in order to be able to measure and improve performances. They allow to know which the most and least popular pages are and to see how visitors move around the website. However, information is collected in an aggregate and anonymous manner and therefore does not allow to identify the user. Under these conditions, performance cookies are equivalent to technical cookies and do not require your prior consent to be set on your device; it is however possible to disable them through the banner displayed on the first visit of our website or through the cookies settings, below this policy.
- **Profiling cookies:** these cookies are set through the website by our advertising partners (**third party cookies**). They are used by these companies to build a profile of your interests and send you advertising messages in line with the preference shown by you in the context of network navigation. Their storage in your device requires your consent. You are free to decline the profiling cookies storage on your device through the banner displayed on the first visit of our website or through the cookies settings, below this policy.

Third party cookies

The setting of cookies belonging to third parties, as well as any other activities related to those cookies, including the collection and processing of information, is responsibility of such third parties. The third parties that may access information collected through their cookies on our website, are

How to disable all cookies

It is possible to choose if allow or not the setting of cookies through the setting section of the browser. However, if one or more cookies are disabled, some features of this website may consequently be affected (please keep in mind that navigation cookies are necessary for the proper functioning of the website basic features). The browser configuration related to this choice may be monitored and modified in the setting panel of your browser.

Information collected by cookies are accessible to the company who owns the Website (which identity and contact data are indicated in the Privacy Policy of this Website) which acts as Data Controller, and to some of its supplier, which acts as External data processor. In the case of third party cookies, information is accessible to the third party who manages the cookies.

Data collected through cookies are stored for 12 months (profiling cookies), 26 months (performance cookie) or 34 months (technical cookies)
